## **Course Description**

All students enrolled in a Bachelor of Music (Individualized, Music Education, or Performance) program are required to take the appropriate section of this course in each year of study. Students in this course must attend a series of department events as prescribed annually, including departmental ensemble concerts, presentations included in the Fine Arts Research Lecture Series (FARLS), and student recitals. Concerts and lectures are scheduled throughout the Fall and Winter terms (dates announced each September), but most student recitals are scheduled in the Winter term only; during the Winter term, students should plan to be available to attend recitals on Mondays, Wednesdays, and Fridays from 12:30-13:30, and Thursdays from 19:30-21:30. Contact the Department of Music (music.department@usask.ca) for more information. Students must attend events in person to receive and event attendance credit.

The requirements for the 2023-24 academic year will be as follows:

Component 1

3 FARLS LECTURES (out of 5)

#### Component 2

3 ENSEMBLE CONCERTS (Students are not allowed to "double up" on ensemble attendance credits when attending duplicate ensemble performances. For example, if a student attends a

Saturday performance of a Music Theatre show, they cannot count the Sunday Music Theatre show as well for ensemble attendance credit.)

#### Component 3

12 RECITAL HOURS (MWF 12:30pm-1:30pm, Th 7:30pm-8:30pm, Th 8:30pm-9:30pm on select dates).

**Note**: 1 hour equals 1 recital credit, regardless of how many recitals take place within that 1 hour; student must remain for all recitals during the hour to receive a recital credit).

## Learning

The purpose of this course is twofold. Firstly, the course ensures that departmental performances have an audience, an important component for students studying live performance. Secondly, attending students will be exposed to a wide variety of repertoire, genres, and styles, which will extend the bredth of their musical learning.

## Grading Scheme

This is a Pass / Fail course. Students who meet the required number of attendance credits for each component will receive a passing grade.

## **Evaluation Components**

Students will need to sign in upon arrival and out upon departure for each event to confirm attendance. Failure to do either of these steps will result in the attendance credit not being counted. For recitals, students will only need to sign in and out once for the whole hour, not for each recital presented. The sign in sheet will be located at the main entrance to the event venue and monitored by one of the department's recital assistants.

## Participation

Students may not receive an attendance credit for an event in which they are a participant.
