WHAT HAVE DEPARTMENT MEMBERS BEEN UP TO RECENTLY?

Joe Garcea was promoted to the position of Associate Professor in July 2000.

Kalowatie Deonandan participated in a DND seminar at the University of Manitoba in January on the future of Canada's Defence Policy and participated at the UN in March as part of a DND delegation examining Canada's peacekeeping role. In February she gave a paper entitled "Cheddi Jagan, Guyanese Marxist: Reformer or Revolutionary" at the Congress of the Canadian Association of Latin American and Caribbean Studies in Antigua, Guatemala.

David Smith presented a paper titled 'Indices of Citizenship' at a conference on A Century of Citizenship in Australia and Canada, sponsored by the Institute for Canadian Studies, University of Ottawa, Feb. 7-9, 2001. He also presented a paper titled 'Second Thoughts on Second Chambers,' to the Australian Studies Association of North America, Georgetown University, Washington, D.C., February 22-24, 2001.

John Courtney participated in a "Seminar on Voter Participation" on February 16, 2001 in Ottawa sponsored by the Centre for Research and Information on Canada. He will deliver a paper on electoral reform to an Ottawa conference in early May sponsored by the Institute for Research on Public Policy.

Cris de Clercy and **Peter Ferguson** are giving a paper in early September on "Pollsters and Hucksters: A Comparative Analysis on Opinion Poll Reporting in the 2000 Canadian and American Elections" to the 97th annual meeting of the American Political Science Association in San Francisco.

Jene Porter was the organizer for the Conference for the Study of Political Thought which was held at the University of Saskatchewan on March 17, 2001. Papers were presented by Professor David Walsh (Catholic University of America), John von Heyking (U of Lethbridge), Barry Cooper (U of Calgary), Leon Craig (U of Alberta) and Camille Slights (U of Saskatchewan).

Russell Isinger was recently awarded \$700 from the U of Manitoba's John S. Ewert Memorial fund, and was also awarded \$2500 from the Department of National Defence's Security and Defence Forum. The money is to support research trips to Ottawa in support of the book on the Avro Arrow that **Don Story** and Russell are writing.

NEW LEGISLATIVE INTERNSHIP PROGRAM

The Saskatchewan Legislative Assembly's Board of Internal Economy approved a proposal from the U of Saskatchewan and U of Regina to establish a new Legislative Internship Program. A total of four third- or fourth-year students from the two universities will spend seven months-January through July-working as assistants to individual Members of the Legislative Assembly, learning about the political process from the inside. The program will start in January 2002. Applications are invited from interested senior U of S students who may be in Political Studies, History, Law, or another related field-and also from recent U of S graduates. Application forms will be available in April 2001, so students can apply and plan their 2001-02 academic year accordingly.

EXCITING CHANGES TO OUR CURRICULUM!

The Department has been involved in the review of its entire curriculum since last fall, and we have already made a number of changes to our program, including the introduction of a minor in Political Studies and the splitting of most of our 4th year seminars into two 3 c.u. courses. We have also dropped a number of prerequisites for some of our 2nd and 3rd year courses.

VISITING LECTURERS

Jane Jenson, Professor of Political Science, Director of the Université de Montréal/McGill University Institute of European Studies, and Director of The Family Network of Canadian Policy Research Networks since June 1999, was this year's Timlin lecturer (6 February, 2001). She spoke on "Social Citizenship in 21st Century Canada: Challenges and Options." Her lecture will be published and available at no charge from the Department.

STRATEGIC PLANNING

The Department has begun a process of strategic planning. The first step involved a Departmental Strategic Planning Retreat in January 2001. The Department will be working on its Action Plan through the balance of the year.

INDIGENOUS PEOPLES & JUSTICE INITIATIVE

The Department is a partner in the new Indigenous Peoples and Justice Initiative, approved by University Council in February 2001. The Department's part in the initiative will be an Indigenous Public Administration Program, which we hope to have up and running by the Fall of 2002. A LUCKY BREAK ...

Library Gets Old Canadian Documents-Quick thinking by Government Publications Head Andrew Hubbertz (a Professional Affiliate in Political Studies), netted the U of S Library a windfall of early Canadian provincial legislative records. Hubbertz says he happened to see an Internet note that the University of Minnesota Library wanted to give away the documents due to lack of space. "We jumped at it," he says-and the result was the receipt of about 90 cartons of old books and documents, in 40 large mailbags, at a cost of just \$1,600 (U.S.) to the Library. Hubbertz says the material may range in value between \$100,000 and \$250,000.
